Frequently Asked Questions...

Is the website safe and secure?

Yes. Information sent via the website is encrypted by DigiCert® to ensure your privacy and security.

Is a sufficient audit trail produced?

Yes. You may print an online receipt with each payment and your payment history is available to view at any time.

How will I know if the withholding payment has been processed?

You can use the website to confirm your payment was received and processed by viewing your payment history.

Can I combine all employee withholdings and remit one payment?

Yes. Remit one payment containing multiple employee withholdings.

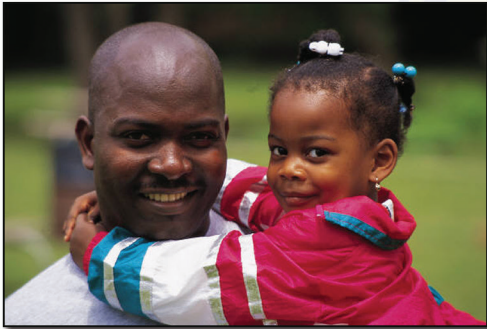

quickly, easily and securely
through the Internet
according to...

Neb. Rev. Stat. §43-3342.03(4): If you have more than 50 employees, any child support payment made on behalf of a single employee must be done electronically.



1. Everyone Benefits

Transmitting employee information and payments electronically through the Nebraska Child Support Payment Center's secure website offers these benefits:

- Saves you time and money.
- Assures banking and data entry accuracy and security.
- Protects confidentiality.
- Enables your employees to be credited for payments faster.
- Most importantly, allows children's needs to be met.

2. Easy to Use

- Go to website and click on **Request Login** and complete the simple registration form to receive ID and password.
- Go online to make payments at childsupport.nebraska.gov/employers

3. Choose How to Pay

- ACH Debit - We debit your bank account according to the amount and date you supply.
- ACH Credit - You contact your bank to have the money sent to the payment center. You tell us how much and when to expect the transfer.
- EFT Payments - We also accept EFT payments using formats, CCD+ or CTX820.
- Check - You send in a check for the payment.
